CONTEST FEES

In addition to the regular conference registration, there will be a contest supplies fee of **\$20.00 per contestant**. This charge is to offset the cost of contest supplies. This fee will be added to the contestant's registration when it is completed online.

DATE, TIME, AND LOCATION

Testing – The Professional Development exam will be given online from March 15 - April 7, 2023. There will be no skill content exam before the competition in 2023; however, students will still need to take the SkillsUSA PDP exam.

Skill Contest – The 2023 State SkillsUSA Collision Damage Appraisal contest will be held on Monday, April 24th and will be hosted at Tulsa Technology Center – Broken Arrow Campus (4000 W Florence St, Broken Arrow, OK 74011)

The contest sign-in will be from 7:30-8:00 a.m. Orientation Meeting - 8:00 a.m.

Contestant Resumes – All contestants will be required to submit a typed resume. If any contestant does not submit a resume to the contest chair, penalty points will be assessed.

TRANSPORTATION

Transportation to and from the contest site **will not** be available. You must make arrangements for transportation.

LUNCH

Due to the contest schedule, lunch will be provided and will take place at the contest site.

CLOTHING REQUIREMENTS

As in the past, skill contestants will not be penalized for not adhering to national clothing requirements. Contestants should not wear clothing that has school identification visible to the judges. Those contestants wearing program uniforms will need to cover all identifying patches.

AWARDS CEREMONY

Contest winners will be recognized during the Awards Assembly on Tuesday, April 25th at the Tulsa Cox Convention Center in the Grand Hall at 9:00 a.m. Official SkillsUSA attire is required. According to the SkillsUSA Championships Technical Standards- official clothing requirements are as follows: "For men: SkillsUSA official attire: Official red blazer or jacket, black trousers, white dress shirt, plain black tie with no pattern or official SkillsUSA tie, black socks, and black shoes. For women: Official red blazer or jacket, black dress slacks or skirt, with a businesslike white, collarless blouse or white blouse e with a small, plain collar that may not extend onto the lapels of the blazer, black sheer or skin-tone hose and black dress shoes. Any contest winner who is not in official SkillsUSA attire will not be permitted on stage. The student will be escorted behind the stage to receive his or her medallion and awards.
