All contestants will submit a digital resume prior to contest day. Contestants will receive an email to the address used to register the contestant for contest with instructions and link to access the SkillsUSA Competitor Portal page. The email will contain contestant's username and contestant number, which are required to login to the Competitor Portal.

Deadline to submit resume is April 22, 2025.

#### LUNCH

Lunch will be provided in your contest area. A lunch fee (\$20) is in addition to the conference registration and any contest specific fees for the contest.

#### **CLOTHING REQUIREMENTS**

Students cannot wear any identifying information on their uniform that will associate them with a school or technology center.

For competitions purposes, Light blue SkillsUSA work shirt, navy pants, black work shoes/boots or your program's designated uniform and footwear. Skirts and high-heeled shoes are not permitted

*Note:* Safety glasses must have side shields or goggles. (Prescription glasses may be used only if they are equipped with side shields. If not, they must be covered with goggles.

#### **INDUSTRY AWARDS**

Prizes are the responsibility of the individual contests. Prizes are not guaranteed and are not supplied at the SkillsUSA Oklahoma state level.

Please contact the chair with prizes that will need to be checked in. Each participating school is expected to furnish an industry award. Industry awards should be labeled with the name and address of the award supplier so that an appropriate "Thank you" may be sent, must be accompanied by an *industry award donation information sheet* (available on the Oklahoma SkillsUSA website). Please bring prizes to the awards area in Conference Hall at the Arvest Convention Center on Sunday, April 27<sup>th</sup> between 12-4pm or Monday, April 28<sup>th</sup> between 8am-5pm.

#### **AWARDS CEREMONY**

Winners will be recognized at the General Session on Tuesday morning, April 29<sup>th</sup> at 9am. All competitors must wear official SkillsUSA dress to the Awards Session, where winners are announced. Competitors who are not dressed appropriately or lack official attire will be denied access to the awards stage. Students must be present when their contest is announced. If a student is improperly dressed, absent, or misses their contest being called, the production will not be paused for any reason, and they will forfeit their opportunity to go on stage to receive the award. No exceptions will be made. No hats or sunglasses will allow to be worn on stage.

- Official dress for men: Official blazer, jacket or sweater; black dress slacks; white dress shirt; plain black tie with no pattern or SkillsUSA black tie; black socks and black shoes.
- Official dress for women: Official blazer, jacket or sweater; black dress slacks or knee-length skirt with business like white, collarless blouse or white blouse with small, plain collar that may not extend onto the lapels of the blazer, and black dress shoes.

## **CRIME SCENE INVESTIGATION PURPOSE**

To evaluate the competency of a crime scene investigation team consisting of

three students/competitors in their ability to process, document, photograph, sketch and search the crime scene. Individual skill level and teamwork will be evaluated.

#### **ELIGIBILITY**

Each chapter may enter one three-person team per instructor consisting of three secondary students who are active SkillsUSA members. Each chapter may enter one three-person team per instructor consisting of three post-secondary students who are active SkillsUSA members. All team members must be from the same SkillsUSA chapter.

Note: Competitors must wear their official competition clothing to the competition orientation meeting.

## **EQUIPMENT AND MATERIALS:**

Supplied by the technical committee:

• <u>Crime scene:</u> All necessary materials for the competition not specified elsewhere.

# **Supplied by the competitors:**

- Digital Camera (not a cell phone) with removable media card
- PPE to include safety glasses, mask/face shield, shoe covers, and examination gloves (*Tyvek optional and preferred not to be used*)
- Latent print examination kit/fingerprint kit with cards and tape
- Measuring device (laser measuring device or tape measure)
- Scale (preferably an 'L' shaped scale)
- Sterile swabs and swab boxes
- Water in dispenser bottle/dropper (should be distilled, but due to travel restrictions can be tap)
- Evidence placards/markers/cones
- Evidence bags; paper and plastic, various sizes
- Tamper proof evidence tape
- Sharpie
- Sketching kit
- Tweezers
- Small pocket notebook for field notes
- Pens and #2 pencils

- Flashlight
- Crime scene kit containing materials necessary to conduct a crime scene investigation. At a minimum.

#### **PROHIBITED DEVICES**

Cell phones or other electronic devices not approved by a competition's technical committee are NOT allowed in the competition area. Any device that can be used to communicate is prohibited, including wearable technology such as smart watches. Technical committee members may also approve exceptions onsite during the SkillsUSA Championships if deemed appropriate.

If a competitor's electronic device makes noise or if the competitor is seen using it at any time during the competition, an official report will be documented for review by the SkillsUSA Championships. If confirmed that the competitor used the device in a manner which compromised the integrity of the competition, the competitor's scores may be canceled.

#### SCOPE OF THE COMPETITION

The competition is defined by industry standards as identified by the SkillsUSA technical committee.

### **KNOWLEDGE PERFORMANCE**

The competition will include a test assessing knowledge from the Standards and

Competencies. Team members test independently and cannot consult with one another during testing. The combined scores of the team total 150 points. See Appendix A for a list of terms for review.

Competitors are also required to take the SkillsUSA professional development test. These scores will comprise 25 points.

## **SKILLS PERFORMANCE**

The competition will include activities that simulate situations encountered by criminal investigation professionals. See Appendix B for a list of examples. The Skills Performance is broken down into four main sections.

<u>Crime Scene Practicum</u> – students will have 15 minutes in a mock crime scene. They will photograph, search, identify evidence, and collect information necessary to record the crime scene. They will not remove evidence. The focus is on the recording stage of crime scene processing. 100 total points in this station.

<u>Paperwork</u> – the students will then complete the crime scene sketch (100 points), photo log (with photos 100 points), property forms, and individual narratives (paperwork is 125 points). Their photos will be collected from their media card for judging. 325 total points in this station.

<u>Skill Demonstration</u> – the team will be given three skills to demonstrate. The team will decide which member will demonstrate which skill. Each member of the team will demonstrate one skill. Each skill can only be demonstrated by one member of the team. Skills might be collecting a type of evidence, processing a type of evidence, or a similar crime scene skill. See Appendix B for a list of possible skills. Each skill is 100 points for 300 points total in this station.

<u>Evidence Interpretation</u> – the team will work together and evaluate or analyze evidence. During this exercise the team may be asked to examine a single article of evidence, a lab result(s), or compare multiple pieces of evidence and then be asked to make the proper conclusion about the evidence. 100 total points in this station.

<u>Note</u> – the competition committee may choose to connect all the events in one common crime event and link all the stations. The only required connection is between the practicum and the paperwork. The Demonstration and Evidence

stations could choose skills and items not connected to the mock crime scene.

## **COMPETITION GUIDELINES**

Each competitor must work independently without assistance from instructors, other teams or observers. Contact with competitors must be coordinated through designated event staff only. Any violation of this may disqualify the competitor. Cell phones, iPads/tablets, smart watches, wearable technology or any other electronic communication device is prohibited in the competition area. See "Prohibited Devices" section above for more information.

No one but competitors, judges and event staff are allowed in the competition area at any time. Observation is limited to the area designated by the judges or event staff. Any outdoor competition area may only be accessed by judges, competitors and event staff. Any violation of this may disqualify the competitor. No one may contact judges in any way and at any time without the expressed permission of the competition coordinator
